The Department for Education Guidance for schools, was only issued late afternoon yesterday. It is important that we try and clarify what it means for our school, students, staff, parents and carers.

With all these changes that we are now having to implement, our paramount concern is for the safety of our children and staff at Worthing High School and with your help and support, I am certain that we will all get through this. We must be guided by Government, Public Health England and DfE and for all of us to understand the implications of the recommendations.

FACE COVERINGS

From Monday 9 November, <u>face coverings must be worn in all communal/transitional areas of the school whenever staff and students are not in lessons. When walking around outside the school buildings, staff and students are permitted to remove their face coverings, but they must ensure as soon as they enter the school building that face coverings are replaced.</u>

This is not a school request, but one from central government and the expectation is that from Monday, as a school, we are fully compliant.

For students who are exempt from wearing a face covering please can you ensure that they have with them their exemption card/lanyard/badge which is clearly visible from Monday. For details on how to obtain or print an exemption card please visit this website

All face coverings worn in school, should be made of plain material only and to adhere with our uniform standards. In line with World Health Organisation instructions, students will be reminded in tutor time tomorrow that hand sanitiser should be used when putting on and removing a face covering.

Please also supply a small sealable plastic bag where the face covering can be stored when not in use. We would also strongly encourage the use of washable masks, as disposable ones have a significant negative impact on our environment.

AFTER SCHOOL CLUBS

ACCESS TO LRC BEFORE AND AFTER SCHOOL

LRC access will continue as accordance with our current arrangements which are:

- Year 7 can access the LRC each day from 8am and from 3.15-5pm and also at lunch time and morning break time
- Other year groups can access on the following days after school only from 15.15-17.00 in the <u>silent reading area only</u>:
- Year 11 Monday
- Year 10 Tuesday
- Year 9 Wednesday
- Year 8 Thursday

CLINICALLY EXTREMELY VULNERABLE STUDENTS

There are 2 ways you may be identified as clinically extremely vulnerable:

- 1. You have one or more of the conditions listed below, or
- 2. Your hospital clinician or GP has added you to the <u>Shielded patients list</u> because, based on their clinical judgement, they deem you to be at higher risk of serious illness if you catch the virus.

Children who live with someone who is identified as clinically extremely vulnerable should still attend school.0

VISITORS TO SCHOOL

We are required to restrict all visits to school unless they are absolutely necessary. Any request a parent/carer makes to visit school will be triaged and may take place virtually rather than face to face.

External visitors to school will also be on an "absolutely necessary basis" only.

HOME/REMOTE LEARNING REMINDER

If students are at home due to illness, or are isolating, they can access all classwork through Microsoft Teams. Go to the relevant Team for the lesson they would have and go to the "Files" tab at the top. Work for some subjects will be posted in the year group Team as opposed to their individual classes Team. Here you will find all the lesson resources.

Please ensure your child submits all completed work to their teachers through Microsoft Teams or by email.

In the event of a whole year group being required to work from home, students should follow their normal timetable and access lessons through Microsoft Teams. At the start of each lesson they need to go to the relevant Team.

A live meeting will start promptly at the start of the lesson (9 am for Period 1, 10:05 am for Period 2 etc.). They need to join this meeting, turn their camera and microphone on but remain silent. A register will be taken. After this their teacher will introduce the topic of the lesson and explain where they will find any resources that they need. They will also tell students how to submit completed work. If students have any questions during the lesson then please ask them to email their teacher directly.

ATTENDANCE

From the start of the autumn term 2020 pupil attendance has been mandatory and the usual rules on attendance have applied. The most recent government announcement on the new national restrictions has not changed the stance on attendance at school. Although school attendance is mandatory, there are some circumstances where pupils cannot attend school due to coronavirus (COVID-19). This category can only be applied when a student does not attend because their travel to, or their attendance at school would be:

- contrary to guidance relating to the incidence or transmission of coronavirus (COVID-19) from Public Health England (PHE) and/or the Department of Health and Social Care (DHSC)
- prohibited by any legislation (or instruments such as statutory directions) relating to the incidence or transmission of coronavirus (COVID-19)

Following the new national restrictions we are still waiting on formal guidance from Department for Education, however schools remain fully open. Should a family choose to not send their child into school contrary to the coronavirus (COVID-19) guidelines set out by government this would be an 'un-authorised' absence.

AREAS CAUSING CONCERN

Please note the following areas have been identified as areas of concern for anti-social behaviour and criminal activity by the police: Hill Barn Golf Club area; Manor Sports Ground and The Lamb park area. We would advise all parents and carers to encourage your child to avoid these areas when out exercising during lockdown

UNIFORM

Please can I ask that all parents refer to our uniform policy (Attached) as we have had a number of students arriving at school in tracksuit bottoms that are not black and hooded sweatshirts which are not permitted in school. Please also note our policy regarding piercings, no piercings other than a stud in each earlobe are permitted. Students are not allowed to pierce other parts of their face or body and if they do so then there will be sanctions issued if the students do not then remove the piercing when asked. Many thanks for your support with this.
